

1. Preamble

Bajaj Finance Ltd. ('BFL', 'Bajaj Finance', nahuile 'The Company'), toh Bajaj Finserv Ltd. laga subsidiary ase. Etu toh deposit-lua Non-Banking Financial Company (NBFC-D) ase Reserve Bank of India (RBI) logo registered ase aru NBFC-Investment aru Credit Company (NBFC-ICC) te classified ase. Arubhi Scale based framework RBI para dekena thakia laga hisab te, BFL toh NBFC laga Upor layer te classified kurikena ase. BFL toh dhar dia aru deposits accept kura laga business te engage kurikena ase.

Company toh alag-alag beshi lending portfolio ase retail, SMEs (small and medium-sized enterprises), aru commercial customers khan te India laga bosti (rural) aru shahar (urban) beshi te thaki kena ase. Company toh Public aru corpoDaam deposits accept kure aru kisim-kisim financial services samaan khan offer kure tai khan laga customer logo te. Pre-paid Payment Instrument (PPI) bhi ase tai khan logo RBI para licence deya laga, Payment & Settlement Systems laga Department para.

Etu document toh outline kure policy ke governance karne, determination aru fees aru charges customer logo lua khan Fair Practice Code laga line te RBI para regulations dekena thakia neshina customer logo transparency thakibo nimate.

3. Fees, charges aru Upfront Interest levy kura Principles aru Procedures karne

BFL para kisim-kisim samaan dhar lua offer kure tai khan laga customer logote. BFL para customer logote Fixed Deposit samaan, kisim-kisim payment samaan aru 3rd party para bhag kura samaan khan offer kure.

Etu neshina, BFL khan para alag-alag fees aru charges khan levy kuribo pare customer logo customer para samaan lui kena thakia hisab te. Fees aru charges customer logo lubole khan toh specified kuribole lage alag-alag Product Program Guidelines (PPG) te.

Samaan khan dhar lua aru sustainability aru business operations te risk consider kura pichete, BFL para alag-alag fees aru charges levy kuribo pare customer laga upor te:

- **Upfront fees aru charges-** Fees aru charges loan processing/ disbursement processing fees, documentation charges, convenience fees, etc. nimate customer logo levy kuribo paribo acquisition stage te. Nature aru quantum enika upfront fees aru charges khan toh alag hubo pare samaan laga upor te. Basis Samaan program enika fees aru charges khan to upfront para jama kuribo lage nahuile loan rokum para kati dibole lage nahuile installment logo jama kuribole lage.;
- **Servicing Laga Fees-** Fees aru charges loan servicing karne NOC charges, loan related documents retrieval charges, etc. khan karne customer laga upor te levied kuribo paribo loan laga homoy te specific service-related karne customers para request kurishe kuile.
- **Contingent fees aru charges-** etu charges khan toh change hubo pare kunba transaction nimate/ kiba event hua karne loan tera laga homoy te pre-payment neshina, foreclosure, terms aru conditions loan laga namana karne, bounce, etc. aru etu charges khan toh levied kuribo paribo enika events khan hua karne.
- **Value Added Services (BFL para Manufactured kura khan)-** Fees aru charges value added services property dossier charges, EMI Card fees, CIBIL TransUnion Report (CTR) etc. khan toh customer logo levied hubo kiniya homoy/ enika value-added samaan khan avail kura homoy/ services khan te. Enika charges khan toh upfront jama kuribo paribo nahuile customer logo funded kuribo paribo; aru
- **Third-party samaan aru services bhag kuriya-** BFL para bhag kuribo paribo kisim-kisim third-party samaan aru services jivon (life) insurance, general insurance, health insurance etc. khan neshina. Etu third-party laga samaan aru services laga daam toh upfront para jama kuribo paribo nahuile customer funded kuribo paribo.

Kisim-kisim fees aru charges alag-alag samaan BFL para dekena thakia khan toh **Annexure 1** laga policy te dekena ase. Actual fees aru charges customer logo lua alag-alag dhar dia aru dusra samaan laga toh Product Program Guidelines (PPG) documents para covered kuri dibo.
