

TERMS & CONDITIONS: CD SOUTH-WEST PONGAL AND SANKRANT JANUARY PROMO  
2022

1. **DEFINITIONS:**

Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“**BFL**” refers to Bajaj Finance Limited.

“**Customer**” means an Indian citizen who avails a loan from BFL during the Offer Period.

“**EMI Card**” shall mean Bajaj Finserv EMI Network Card which enables customers to avail loan from BFL.

“**Offer Period**” shall mean the period commencing from 12:00 am on 14<sup>th</sup> January, 2022 to 11:59 PM on 17<sup>th</sup> January, 2022.

“**Participating Store(s)**” shall mean retail store(s) empaneled with BFL and participating in this Promotion and contribute to the Reward as detailed in clause 3 below.

“**Promotion**” shall mean the “CD South West Pongal and Sankrant January Promo 2022” promotional program offered by BFL for its EMI Customers during the Offer Period.

2. **Customer Eligibility:**

#### **Cashback**

- Customer shall search 'Bajaj Finserv' on Google Play Store and download the Bajaj Finserv Wallet application.
- If you are existing user having active Wallet, then please enter your mobile number and proceed with the One Time Password received on your mobile number
- On the homepage of the application, Customer shall click on the 'Wallet' icon and on the 'Wallet Setup' page fill in the necessary details which are- DOB, ID Type (PAN Card, Voter ID etc), ID number and 'Submit'
- After that, the Wallet will get activated. Once the cashback is credited to Customer's Wallet, the same will be reflected in the Wallet Balance inside the Wallet..
- In case the Customer is an iOS user, cashback will be credited to the Customer's bank account registered with BFL.

#### **Mobile Recharge/DTH Recharge Vouchers:**

- Customer shall search 'Bajaj Finserv' on Google Play Store and download the Bajaj Finserv Wallet application.
  - If you are existing user having active Wallet, then please enter your mobile number and proceed with the One Time Password received on your mobile number
  - The Recharge/DTH codes will be lying locked in the Rewards section of the application. Once you become eligible for the same, you can redeem the codes.
  - You can use then use the redeemed codes for availing benefits against mobile/DTH recharge.
  - Additional terms and conditions of the wallet and Mobile/DTH companies shall apply separately for their respective products and services.

The Cashback fulfilment will be processed within 30 days from the date of transaction in BFL Wallet and if BFL is unable to process cashback amount in customer's Wallet due to any technical issue, then the Reward fulfilment will be processed in the bank account of the Customer registered with BFL.
