

When does this policy protect you?

- It ensures you are covered up to ₹ 50,000 for specific vector borne disease related hospitalisations
- It protects you in the case of Malaria, subject to a confirmed positive blood test for Malarial Parasite
- It covers you in the case of Dengue, subject to a confirmed positive Dengue serology

How many ways does it protect you?



Hospitalization expenses up to Sum Insured of ₹ 50,000, for specified vector borne diseases



Diagnostic Tests during hospitalization or as a pre hospitalization expense



Doctor's Fees during hospitalization or as a pre and post hospitalization expense

Treatment charges including room rental, ICU, transfusion, doctor fees, medicines and tests

- We shall not be liable to make any payment under this Benefit for the hospitalization other than specified vector borne diseases

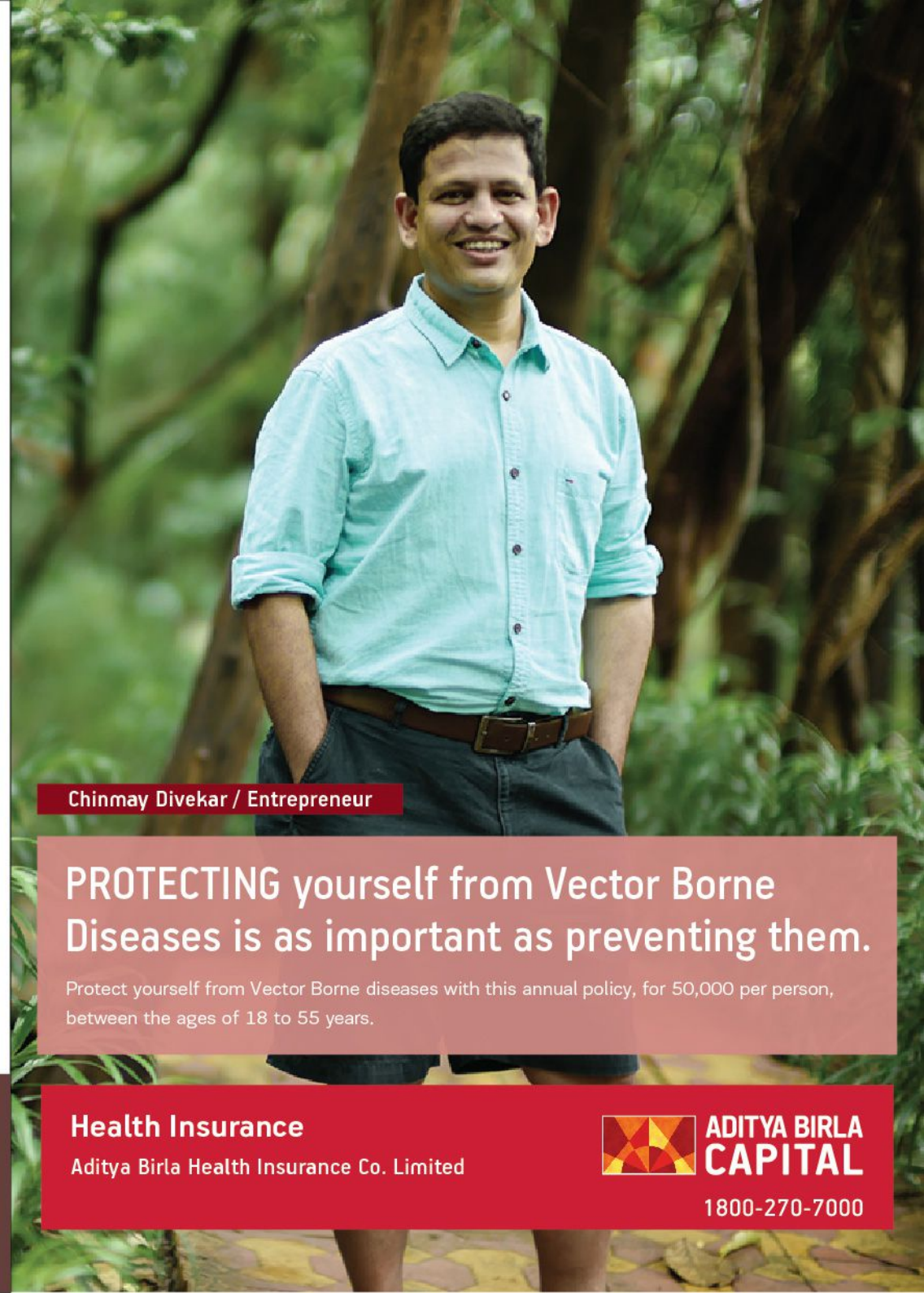
