20. Duration of Auction sale:

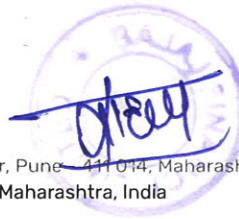

in form 16 B. The purchaser has to produce the proof of having deposited the income tax into the government account.

24. **Default of Payment:**

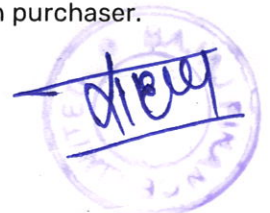
