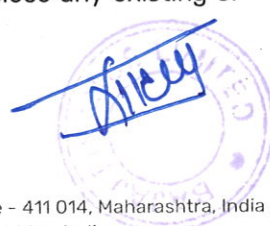

- f. Incomplete/unsigned bids without capturing EMD remittance details will be summarily rejected.
