



- c. All intimations to bidder/auction purchaser will be primarily through e-mail by the Service Provider/ BFL. Date of sending e-mail will be considered as date of intimation. If no intimation reaches, bidders are expected to take efforts to find out status from Service Provider/BFL. Non-receipt of intimation should not be an excuse for default/nonpayment.
- Deposit of purchase price: 21.
  - a. The bidder declared successful, shall pay, immediately on the same day or not later than the next working day after such declaration, a deposit of 25% (less EMD already paid) on the amount of his purchase money.

Return of EMD: 24

EMD of unsuccessful bidders will be returned by BFL into their respective bank accounts, а details of which provided by the potential bidders at the time of submission of bid.

Stay/Cancellation of Sale: 25. In case of stay of further proceedings by DRT/DRAT/High Court or any other Court, the auction may either be deferred or cancelled and persons participating in the sale shall have no right to claim damages, compensation or cost for such postponement or cancellation.
