

- e. Bidder(s) staying abroad/NRIs/PIOs holding dual citizenship must submit photo page of their valid Indian Passport.
- Incomplete/unsigned bids without capturing EMD remittance details will be summarily
- q. Only copy of PAN Card, Passport, Voter's ID, Valid Driving License or Photo Identity Card issued by Govt, will be accepted as the identity document and should be submitted along with the bid form.
- h. Original Identity Document, copy of which is submitted along with the bid form must be produced on demand.

#### 17. Bid Multiplier:

The bidder(s) shall increase their bids in multiplies of the amount specified in the public sale notice/Terms and condition of Sale.

#### **Duration of Auction sale:** 18.

#### 21. Deposit of purchase price:

- a. The bidder declared successful, shall pay, immediately on the same day or not later than the next working day after such declaration, a deposit of 25% (less EMD already paid) on the amount of his purchase money.

25. Stay/Cancellation of Sale:
