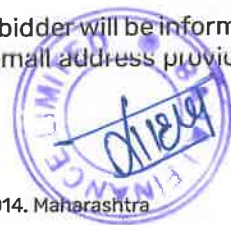

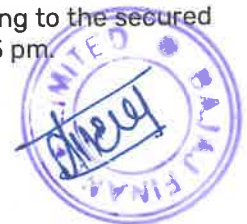

16. Submission of bid forms:

20. Declaration of successful bidder:
