

## **TERMS & CONDITIONS: EMI Travel Fiesta 16<sup>th</sup> March- 22<sup>nd</sup> March' 18**

### **1. DEFINITIONS:**

Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“**BFL**” refers to Bajaj Finance Limited.

“**Customer**” refers to an existing customer of BFL who holds a valid EMI Card.

“**EMI Card**” shall mean the BFL Existing Member Identification Card issued to BFL’s customers.

“**Offer Period**” shall mean the period commencing from 12:00 am on March 15<sup>th</sup> 2018 to 11:59 pm on 22<sup>nd</sup> March, 2018.

“**Platform**” shall refer to the website and/or mobile application owned and operated by **MakeMyTrip India Pvt Limited**

“**Promotion**” shall mean the “**EMI Travel Fiesta**” promotional program offered by BFL for its Customers on the Platform during the Offer Period.

“**Reward**” refers to the reward offered to the Customer(s) under this Promotion.

2. To participate in this Promotion and to be eligible to receive a Reward, a Customer should have mandatorily performed all of the following during the Offer Period:
  - i. availed a minimum loan of Rs. 8000/- (Rupees eight thousand only) or above from BFL for booking Domestic/International Hotel room(s) and/or Domestic/International flight ticket(s) and/or Domestic/International holiday packages through MakeMyTrip Platform during the offer period using the Bajaj Finserv EMI Card.
  - ii. Customer shall apply the Coupon Code named “**Bajaj EMI**” at **MakeMyTrip** platform while making the payment. The Coupon code can be applied only when the customer opt for Bajaj Finserv Payment option.
3. Under this Promotion, every Customer who fulfills the criteria specified by BFL, shall be eligible for an assured instant discount of Rs.200 on their amount of the transaction.
4. This Promotion is available only in select cities of India and is valid only for Indian citizens.

8. The Customer shall receive the instant Rs.200 off while making the payment at MakeMyTrip for flight/hotel booking selecting the Bajaj Finserv payment option at the payment page of MakeMyTrip, payable to BFL for the loan availed under the Promotion.
9. In case of default or delay in the payment of the first EMI or cancellation/refund of the qualifying loan transaction, the Customer shall not receive the Reward under the Promotion.

Where the Customer has provided any incorrect information at the time of registration for the Promotion and/or at the time of collecting his/her Reward, then his/her selection is subject to cancellation without notice, at the sole discretion of BFL

10. All applicable taxes, fees and levies (excluding 'gift' tax or tax deducted at source, where applicable) will need to be solely paid by the Customer(s).
11. The tax deducted at source in respect of the Reward, where applicable, shall be paid by BFL.
12. This Promotion is a special offer for BFL Customers only and nothing contained herein shall prejudice or affect the terms and conditions of the EMI Card and/or Customer loan agreements. These terms and conditions shall be in addition to and not in derogation to the terms and conditions prescribed by BFL for the loan and/or EMI Card.

Notwithstanding anything contained in the Promotion or these terms and conditions, any images, representations etc. and all intellectual property rights pertaining thereto which belong to any third party, shall continue to vest with such party and by using such images, representations etc., BFL in no way claims any right whatsoever relating to such intellectual property.
14. Nothing herein amounts as a commitment by BFL to provide further or similar schemes or offers.
15. BFL is not an issuer/provider of the products purchased/services availed by the Customer on the Platform under this Promotion. Accordingly, BFL shall not be responsible for the quality or any assurances and/or representations made in relation to such products/services provided by third parties on the Platform.
16. Notwithstanding anything herein, BFL shall not at any time be responsible or held liable for any loss, injury, damage or harm suffered by or in connection with, the products/services provided by third parties on the Platform.
17. Disputes, if any, regarding the products purchased or services availed by the Customer on the Platform and under this Promotion must be addressed in writing by the Customers directly to MakeMyTrip and BFL shall not entertain any communications in this regard.
