A. STATEMENT & PURPOSE:

- Bajaj Finance Limited (Company), as a responsible corporate citizen, is conscious of the direct and indirect impact of its operations on the environment.
- The Company is committed to reduce any negative impact on the natural environment and climate change.
- The Company shall endeavor to integrate sound environmental practices and governance systems in it's day to day operations to minimize environmental impact.
- The Company shall engage/encourage its employees, customers and shareholders to adopt environment-friendly practices.
- The Company shall endeavor to monitor, measure, report the progress, performance of environmental conservation and management initiatives in compliance with recognized protocols and communicate achievements to relevant stakeholders.

B. AUTHORITY & RESPONSIBILITY:

This policy may be reviewed and amended from time to time in line with the changes in the regulatory requirements as well as changes in Company's policies and all material changes will be placed before the ESG Committee for an approval.

C. EFFECTIVE DATE:

This Policy shall be effective from the date of approval by the ESG Committee and shall supersede any prior policy or understanding or statement in this regard.

D. OUR ENVIRONMENTAL COMMITMENTS:

The Company is committed to contribute towards ensuring a clean and sustainable environment by continuously improving its environmental performance. To achieve this goal, the Company is committed to:

1. Compliance: The Company shall comply with all the relevant environmental laws and regulations applicable to its business operations in letter and spirit.

2. Optimum Use of Energy and Emissions Management:

The Company shall endeavor to take initiatives in line with best technologies and practices towards:

- i. efficient use of natural resources and energy;
- ii. reduce its greenhouse gas (GHG) emissions;
- iii. reduction and prevention of pollution;

- iv. promoting waste avoidance, recycling measures and environment friendly waste management methods;
- v. promoting products and services that result in less energy consumption and emissions;
- vi. adopting energy efficient operating procedures for facility management and travel;
- vii. explore opportunities for environment friendly procurement practices;
- viii. encouraging use of electronic methods of communications within and outside offices and discouraging use of paper to make a positive difference.

3. Water & Waste Management:

- **6. Credit/Investment Policy:** The Company shall make efforts to make investment/lend in a responsible manner which has a positive impact directly or indirectly on the environment.

7. Exclusion List:

The Company commits to ensure that funds will not be used to finance the following type of activities and/or end use for all line of businesses and specific activities for its commercial lending business as enumerated below:

All line of businesses:

- Manufacture and marketing of banned drugs;
- Dealing in narcotics;
- Dealing in banned wildlife related products;
- Production and distribution of pornographic material;

- Production or trade in any product or activity deemed illegal under host country laws or regulations or international conventions and agreements, or subject to international bans;
- Production or trade in radioactive materials;
- Any sort of unlawful activities.

Commercial lending business:

In addition to above exclusion list for all kind of businesses, the Company shall ensure to not to fund to entities engaged in below line of businesses:

- Stand-alone manufacture and marketing of gutkha and tobacco;
- Polluting industries unless the units have clearance from pollution control authorities and have installed effluent treatment plants;
- Standalone Casino, and Gambling / Betting in any form;

Do's and Don'ts:

1	Do's
•	If you have a choice, pick a paper bag/cloth bag over plastic bags
•	Switch to energy – efficient light bulbs
•	Buy high energy star appliances and equipment
•	Make use of stairs instead of lift
