# CAG to investigate corruption in BMC, Fadnavis tells House

### **YOGESH NAIK** MUMBAI, AUGUST 24

DEPUTY CHIEF Minister Devendra Fadnavis on Wednesday announced a probe by the Comptroller and Auditor General (CAG) into the alleged corruption in Brihanmumbai Municipal Corporation (BMC). He was speaking in the Assembly while replying to a debate on issues pertaining to the Mumbai Metropolitan Region.

The discussion began on Tuesday with BJP legislators making a slew of allegations of corruption in the BMC and they were supported by some Congress legislators as well.

Fadnavis said the issue of BMC officers floating companies in their relatives' names and bagging tenders during Covid times would be probed by an officer of the state urban development department and a report would be given in a timely manner. Fadnavis said, "Prima facie, I think there are irregularities in

this." Pointing out that out of Mumbai's 1,900 kms of road, 1.200 kms are still made of asphalt, Fadnavis said all the roads will be concretised in the next

Shinde orders ACB probe into delimitation of wards

#### **EXPRESS NEWS SERVICE** MUMBAI, AUGUST 24

CHIEF MINISTER Eknath Shinde has announced a probe by the Anti-Corruption Bureau (ACB) into the delimitation of BMC wards, following allegations that the exercise was carried out to help the Shiv Sena.

Shinde made the announcement in the legislative assembly as the amendment to the BMC act, aimed at reducing the number of seats in the civic body from 236 to 227, was passed. Shinde said the Congress, Samajwadi Party and the BIP were "having problems" with the delimitation. He said as many as 892 complaints had been filed against the revision in the BMC ward structure.

Earlier. Mahim MLA Sada Sarvankar had alleged irregularities in the delimitation of BMC wards and demanded an (ACB) probe. Sarvankar, who belongs to the Shinde faction, said in the Mahim assembly seat, a few wards were transferred to the Worli segment represented by Aaditya Thackeray. Shinde said, "The census is done every 10 years and the increase in the number of wards takes place accordingly. There is an anomaly that the six wards were increased for 20 per cent population while nine wards for 3.8 per cent population." FULL REPORT ON

## Congress alleges scam in road repairs, seeks **CBI** probe

THE CONGRESS has continued with its attack on Wednesday against Brihanmumbai Municipal Corporation (BMC) during the tenure of its Maharashtra Vikas Aghadi (MVA) partner, Shiv Sena.

Congress leader Milind Deora demanded a CBI probe into BMC's expenditure on the roads department in the past five years.

This comes a day after MVA demonstrated its unity with a meeting at Vidhan Bhavan on Tuesday, the first among the allies since the collapse of the government in lune.

On Wednesday, Deora said BMC has spent Rs 14,000 crore on road repair between 2017 and 2022, which is 10% of the budget of National Highway's Authority of India. Taking to social media on Wednesday, he said, "Between 2017-22, @mybmc


# Shelar seeks probe into tenders for virtual classrooms in BMC schools



# Soon, no mid-day meal without Aadhaar card

### **PALLAVI SMART** MUMBALAUGUST 24

THE STATE government is receiving a lot of flak from the education sector for its recent decision to provide midday meals only to students with Aadhaar cards even as it has given until the year-end for schools to complete the process.

Pointing out how the midday meal scheme has been a factor for enrolment in schools, especially in rural or tribal dominated areas, a government school teacher said, "This is inappropriate and not in line with the Right To Education (RTE) act. Moreover, there is no such clause by the Centre which runs the policy," adding, "Putting such a condition is going to have an impact."

Last month, the Directorate of School Education (Primary) issued orders to local education department offices of all districts. According to the order, schools have to submit updated data of Aadhaar card registration of their students at the end of every month until November 2022. The aim is to collate the data before December 2022 which is the deadline to complete Aadhaar registration. According to teachers, the other government schemes at schools are likely to follow the same diktat.

available Teachers also pointed out that

work does not end at registration of Aadhaar. "It has to be verified too," said Mahendra Ganpule. Maharashtra State from Headmasters' Association. He explained, "A child may have an Aadhaar card but it has to be verified on details such as name, birthdate, gender. If these details, on Aadhaar and in school enrolment do not match, the said Aadhaar registration is not considered valid. Now these are technical details, and there could be various reasons which may have led to a mistake. It is not right to decide if a child can be served a midday meal or not based on these technicalities, especially when it has been a driving factor for many parents to enrol

their children to schools.' According to state-wide data shared by Ganpule, out of 1,89,94,363 students with Aadhaar enrolment, only 89 29 525 have valid Aadhaar count. And out of total student enrolment count of 2,24,50,469

Vijay Kombe, a Zilla Parishad School teacher from Wardha district who is also the secretary of Maharashtra State Primary Teachers' Association, said, "These technical mistakes are rampant in rural areas. Most parents won't even know how to spell a name in English. Many times, illiterate parents have to depend on the operator to fill in the correct information. Many students in tribal belts don't have an Aadhaar card."

Meanwhile, the directorate is firm on its stand. Director of Education (Primary) Dinkar Temkar, who looks after the middav meal scheme in Maharashtra. said, "There is no Aadhaar mandate for school admissions. But in order to avail the facilities, students will need to have valid Aadhaar registration. There have been instances in the past when schools have forged the data of student count. The verification process for valid Aadhaar registration is important to ensure that the given

12-digits is a correct Aadhaar card number and is not repeated in any other school.'

# 'Decide on appeal against dissolution of Sharad Pawar-led Maharashtra Wrestling Association committee'

THE BOMBAY High Court on Wednesday directed the Maharashtra State Wrestling Association (MSWA) to file an appeal before the President of Wrestling Federation of India (WFI) challenging "sudden dissolution" of MSWA's elected executive committee led by Nationalist Congress Party (NCP) chief Sharad Pawar. The WFI, in its response to MSWA's plea, stated that the Maharashtra Association can exercise the option of remedy of appeal before the president of WFI.

The court noted that the MSWA will have to file an appeal within 10 days and that the appellate authority will decide the same within 30 days thereafter.

Moreover, the counsel representing WFI said that it will continue its earlier undertaking that it will not declare election results for the new committee and the same will be maintained till a period of 10 days after the appeal is disposed of.

Passengers have been gathering outside the Badlapur railway station manager's office and shouting slogans demanding suspension of the AC local trains and resumption of non-AC trains.

Following the protests, the CR on Wednesday decided to suspend the AC service.

The passengers are upset with the Railways as it is cancelling or replacing the non-AC train services after the introduction of AC train services. The passengers claim that very few people afford to travel by AC trains and due to lesser non-AC trains crowd in the non-AC trains is increasing.

Several political leaders, including NCP leader Jitendra Awhad and Supriya Sule, had tweeted in the passengers' support. Currently, a total of 56 AC train services are run by the Central Railway and with the addition of the 10 new AC services it would have been 66 AC local train services. "The earlier 56 AC trains will run according to schedule," said a senior railway official. The Central Railway runs a total of 1,810 local train services on the Mumbai suburban network and caters to over 40 lakh passengers every day.

## **DHFL-YES BANK CASE** Accused sent to jail for not complying with bail procedure

#### **EXPRESS NEWS SERVICE** MUMBAI, AUGUST 24

A SPECIAL CBI court on Wednesday sent an accused in the DHFL-Yes Bank case into judicial custody for not complying with the bail procedure.

Satyan Tandon, a builder, was arrested in the case in May. On the day of his arrest itself, the court had sent him to judicial custody and he was sent to JJ Hospital due to mental health issues. He was subsequently granted bail.

Among the conditions set for his bail was the requirement to furnish surety. The last date for this was August 12. Since there were consequent public holidays, his lawyers were directed to file for extension in time period to file surety as he was not able to arrange it within the given time.

On Wednesday, the court said that this was not done. "As on today, accused has committed breach of the bail order. He has not complied the terms of bail order which are required to be complied on or before August 17," special judge SUWadgaonkar said, stating that there were grounds to arrest Tandon and send him to judicial custody. He was remanded to judicial custody till August 26.

HC: Touching child's private parts with	
sexual intent enough to see it as assault	

#### **OMKAR GOKHALE** MUMBAI, AUGUST 24

THE BOMBAY High Court, while dismissing an appeal of a man convicted for sexual assault of a five-year-old girl in 2013, recently said that as per the Protection of Children from Sexual Offences (POCSO) Act, even touching the private parts with sexual intent is sufficient to construe it as sexual assault.

The court noted that the absence of injury in the victim's medical certificate will not make a difference to her case as the crime fell within the purview of the POCSO Act.

A single-judge bench of Justice Sarang V Kotwal passed an order in an appeal by the man who was in November, 2017, convicted by special POCSO Act court in the city for offences punishable under section 354(assault or criminal force to woman with intent to outrage her modesty) of the Indian Penal Code(IPC) and section 8 (sexual assault) of the POCSO Act. He was sentenced to

five years of rigorous imprisonment. As per the prosecution, in December 2013, the man picked up the girl from outside her house, and touched and pinched her private parts. The girl narrated the incident to her mother, who took her to the hospital and later, the police station. The mother lodged an FIR and the

girl's statement was also recorded under section 164 of the CrPC. The appellant was apprehended by the people and was brought to the police station, after which he was arrested.

In his defence, the appellant, through advocate Sushant Mhatre, stated that he was falsely implicated by the girl's father following a quarrel with him. Mhatre argued that the FIR was filed with a two-day delay, adding the same remained unexplained. Mhatre added that the medical examination of the victim did not reveal any injury and therefore, the prosecution's case was doubtful and his conviction be set aside. After perusing the submissions,

Justice Kotwal noted, "The victim has

WITH RAJASTHAN Chief Minister Ashok Gehlot emerging as the choice of the Nehru-Gandhi family to succeed Sonia Gandhi as the Congress president, the possibility of a contest for the top post cannot be ruled out, sources said. If the 71-year-old Gehlot files his nomination with the obvious backing of the Gandhis, sources said the G-23 could field a candidate to challenge him. Ending all speculation re-

garding election to the post, the Congress Wednesday announced that a meeting of the Congress Working Committee (CWC) will be held virtually on Sunday to "approve the exact schedule of dates for the election of the Congress president". Sonia Gandhi, who is abroad for a medical check-up, along with Rahul and Priyanka Gandhi Vadra, will preside over the crucial meeting. The decision to convene the

CWC came a day after Gandhi met Gehlot, a three-time Chief Minister. With Rahul not keen to return to the helm, Sonia reportedly told the Raiasthan CM to take over the leadership of the party. Gehlot is said to be reluctant as he may have to leave the CM's post in the event of him taking over as party chief. For the Congress, Gehlot fits

Sources in the G-23, however, did not rule out the possibility of the group forcing a contest. The last time an election in the real sense was held for the post of Congress president was way back in 2001, when Jitendra Prasada contested against Sonia. He was

defeated by 7,448 votes to 94. In 1997, Sitaram Kesri had faced a challenge from heavyweights Sharad Pawar and Raiesh Pilot. He defeated them easily by securing 6,224 votes against Pawar's 882 and Pilot's 354 respectively.

Although it will be an uphill battle, the G-23 believes that putting up a candidate against the official nominee, even if it is the veteran Gehlot, is important to prove a political point – that it is the "system" and the "style of running the party" which needs to change and not the face.

Sources said Ghulam Nabi Azad's decision to decline the chairmanship of the campaign committee in I&K and Anand Sharma's resignation as head of the steering committee for the Assembly elections in Himachal Pradesh were signs of things to come.

Gehlot, meanwhile, sought to downplay the talk that he could be made Congress chief. 'This has been doing the rounds in the media for a long time. You keep talking about it. Nobody knows what is going to be decided," he said.

Gehlot said he is concentrating on the two responsibilities given to him - as senior observer for the coming Gujarat Assembly polls and CM of Rajasthan. "Has anybody briefed you at the AICC? No one has done that. Media keeps on speculating. Till a decision is made, neither you nor I can comment on it." he said
