

## Terms and Conditions -Rural-Two-Wheeler

### Rewards

DEFINITIONS: Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“BFL” refers to Bajaj Finance Limited.

“Bajaj Finserv App” shall mean the mobile based application made available by BFL.

“Customer” means an existing customer of BFL who an Indian citizen is who avails a loan from BFL during the Offer Period.

“Offer Period” shall mean the period commencing from 10<sup>th</sup> June’24 up to 24<sup>th</sup> June’24 and will be mentioned on the lock/scratch card.

“Promotion” shall mean the “Two Wheeler-June’24 Summer Promo” promotional program offered by BFL for its Customers during the Offer Period for purchasing a Two-Wheeler by availing loan from BFL.

“Reward” refers to Cashback reward offered to the eligible Customer(s) under this Promotion.

“Wallet” refers to the Bajaj Pay Wallet issued by BFL to the Customer in which the Customer can receive and redeem the Reward.

### Customer Eligibility: -

Under this Promotion, every Customer who fulfils all the below mentioned criteria shall be eligible for the Reward:

1. Who mandatorily avail a loan from BFL and book Two-Wheeler from dealers located at the selected cities of India during the Offer Period
2. Who downloads the Bajaj Finserv App and creates a Bajaj Pay Wallet. Bajaj Pay Wallet should be active during Offer Period and for next 30 days after Offer Period
3. Who do not have any “cancelled loan” or “loan under process” after expiry of Offer Period. A cancelled loan or loan under process shall mean a loan which is cancelled, or which does not get approved before expiry of Offer Period respectively.
4. Promotion is applicable only, if the selling dealers through which the Two Wheelers are purchased are located in the locations specified under Annexure 1.
5. Offer is applicable for Bajaj App Active only to whom scratch /lock card is issued.
6. The Product/is/are not returned by the Customer.
7. The Product/s purchased by the Customer is/are duly delivered and is not cancelled by the Customer.
8. The offer under this Promotion cannot be clubbed with any other active offers available during Offer Period
9. Applicable on selected customers who are communicated and shared the lock/scratch card via SMS / notifications over Bajaj Finserv App.
10. The scratch/lock card is unlocked within 48 hours of disbursement of the loan.

Upon fulfilment of all the criteria specified by BFL under these terms and conditions, including as mentioned in clause 2 and below mentioned criteria against the Offer in

accordance with these terms and conditions, Customers shall be eligible for the following Reward:

1. Two Wheeler cashback upto Rs.1000/-

Cashback upto amount Rs.1000/- upon minimum loan amount of Rs 90000/-& above.

2. Bajaj Coins each coin : 0.20paise = 500 coins i.e Rs.100/-

Offer Period - The Voucher offer is a limited period and will be mentioned on the lock/scratch card. 10th June'24-24th June'24.

Eg: Offer valid from 12:00 AM 10<sup>th</sup> June'24 to 11:59 PM 24<sup>th</sup> June'24. The Voucher offer is a limited period and will be mentioned on the lock/scratch card. 10th June'24-24th June'24. The reward will be credited/Offer Unlocked in eligible and qualified customers Bajaj pay wallet within the offer period mentioned above (loan should be successfully disbursed ).

1. One Bajaj Coin carries equivalent value of 20 Paisa, which is not withdrawable as cash
2. The Term Bajaj coins denotes the reward which could be redeemed only on Bajaj Pay wallet and on Bajaj Finance App only

4. Bajaj coins once converted as cash into sub-wallet but cannot be converted into Bajaj coins.

- i. Customer shall search 'Bajaj Finserv' on Google Play Store / Apple App Store and download the Bajaj Finserv App and set up Wallet.
- ii. If you are existing user having active Wallet, then please enter your mobile number and proceed with the One Time Password received on your mobile number
- iii. On the homepage of the application, Customer shall click on the 'Wallet' icon and on the 'Wallet Setup' page fill in the necessary details which are- DOB, ID Type (PAN Card, Voter ID etc), ID number and 'Submit'.
- iv. Subsequently, the Wallet shall be activated. After the cashback is credited to Customer's Wallet, the same will be reflected in the Wallet Balance. SMS of this credited amount will be sent to the Customer.
- v. If wallet is not activated, cashback will be credited to the Customer's bank account registered with BFL.

Reward fulfilment related information will be communicated to Customer/s through SMS on the registered mobile number of the Customer/s by BFL.

This Promotion is available in selected cities / locations of India as enumerated in Annexure 1 below and is valid only for Indian citizens.
