TERMS & CONDITIONS: Khosla Navratri Diwali Promo 2021

1. **DEFINITIONS**:

Following words shall for the purpose of these terms and conditions, be defined to mean as below:

- "BFL" refers to Bajaj Finance Limited.
- "Customer" means an Indian citizen who avails a loan from BFL during the Offer Period.
- "EMI Card" shall mean Bajaj Finsery EMI Network Card which enables customers to avail loan from BFL.
