

Master Terms and Conditions -Rural

Rural Rewards

DEFINITIONS: Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“BFL” refers to Bajaj Finance Limited.

“Bajaj Finserv App” shall mean the mobile based application made available by BFL.

“Customer” means an Indian citizen who avails a loan from BFL during the Offer Period. “Offer Period” shall mean the period commencing from the day of receiving the lock/scratch card to the validity mentioned in the lock/scratch card

“Promotion” shall mean the “RCD-April’24 Summer Promo” promotional program offered by BFL for its Customers during the Offer Period.
