HC stays razing of 280 hutments

Mumbai: A Bombay HC vacation bench, in an interim order on Friday, stayed demolition of hutments on mangrove land at Bheemacharya Nagar, Vikhroli (E). A bench of Justices Nitin Sambre and Prakash Naik directed the slum-dwellers to maintain a status quo, which means they cannot rebuild their homes.

"Considering that no action for removal of encroachment is taken for last 15 years, it will be appropriate to direct the state to stay their hands up to June 6, 2018, till the petition is heard on merit," said the bench. The petition said 280 hutments were to be demolished by the state forest department to implement a 2004 HC order for removal of encroachments from mangrove land. TNN
