WHAT IS COVERED?

Under this scheme during the policy tenure, if the insured person suffers an Injury due to an accident and as a solo and direct impact of that Injury, the Insured person undergoes medically necessary treatment of the following line of treatments.

Physiotherapy, Acupuncture and Acupressure, Chiropody and Chiropractic, Osteopathy, Homeopathy, Ayurveda, we will pay the reasonable and customary charges for the medically necessary treatment, if prescribed by a medical practitioner and opted under the policy.

Description of Treatments:

1) Physiotherapy: Treatment of an Illness, Injury or deformity through physical methods such as massage, heat treatment, etc.

2) Acupressure: The application of pressure (as with the thumbs or fingertips) to the same discrete points on the body stimulated in acupuncture that is used for its therapeutic effects (such as the relief of tension or pain).

3) Acupuncture: Acupuncture is a form of alternative medicine in which thin needles are inserted into the body for treatment of various physical and mental conditions.

4) **Chiropody:** A specialty supplementary to medicine devoted to the care of the feet and the treatment of minor foot complaints such as ingrowing toenails, bunions, plantar warts, foot strain, flat feet and the care of the feet of diabetics.

5) Chiropractic: A system that, in theory, uses the recuperative powers of the body and the relationship between the musculoskeletal structures and functions of the body, particularly of the spinal column and the nervous system, in the restoration and maintenance of health.
6) Osteopathy: A system of medicine based on the theory that disturbances in the musculoskeletal system affect other bodily parts, causing many disorders that can be corrected by various manipulative techniques in conjunction with conventional medical, surgical, pharmacological and other therapeutic procedures.

7) Homeopathy: A system of complementary medicine in which ailments are treated by minute doses of natural substances that in larger amounts would produce symptoms of the ailment.

8) **Ayurveda:** A science of life based on the Vedas, the Hindu books of knowledge and wisdom. It is the traditional Hindu system of medicine (incorporated in Vedas), which provides an integrated approach for prevention and treatment of illness trough lifestyle interventions and natural therapies.

Prohibition of Rebates (under section 41 of Insurance Act, 1938, as amended):

(1) No person is allowed or offer to allowed, either directly or indirectly, as an inducement to any person to take or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer.

(2) Any person making default in complying with the provisions of this section shall be liable for a penalty which may extend to ten lakh rupees.
