

TERMS & CONDITIONS:

1. DEFINITIONS:

Following words shall for the purpose of these terms and conditions, be defined to mean as below:

“**BFL**” refers to Bajaj Finance Limited.

“**BFL Platforms**” shall mean the all the platforms as listed in **Schedule I** below, through which the customer can initiate a request for availing Finance Facility from BFL.

“**Bajaj Finance App**” shall mean the mobile based application operated by BFL, for enabling its customers to avail products/services including but not limited to finance facility from BFL.

“**Customer**” refers to the customer of BFL who wishes to avail Finance Facility from BFL, and has submitted his/her details for same with BFL, during the Offer Period.

“**Finance Facility**” shall mean the finance facility of personal loan, that the Customer wish to avail from BFL, through BFL Platform.

“**Offer Period**” shall mean the respective periods beginning from 9:00 am on __28th July 2021__ until 11:00 pm on __30th July 2022_____.

Notwithstanding anything contained in the Promotion or these terms and conditions, any images, representations etc. and all intellectual property rights pertaining thereto which belong to any third party, shall continue to vest with such party and by using such images, representations etc., BFL in no way claims any right whatsoever relating to such intellectual property.

16. The decision of BFL selection committee in selecting the Customers eligible for a Reward will be final and binding on the participating Customers.
